3 The General Assembly of North Carolina enacts:

5 **PART I. BUSINESS TAX CHANGES**

6 **SECTION 1.1.(a)** G.S. 105-121.1 is repealed.

7 **SECTION 1.1.(b)** This section is effective for taxes due on or after April 1, 2017.

8 **SECTION 1.2.** G.S. 105-129.26(a) reads as rewritten:

9 "(a) Major Recycling Facility. – A recycling facility qualifies for the tax benefits provided
10 in this Article and in ~~Article 5~~ Articles 5 and 5F of this Chapter for major recycling facilities if it
11 meets all of the following conditions:

12"

13 **SECTION 1.3.(a)** G.S. 105-130.4(s) reads as rewritten:

14 "(s) All apportionable income of an air transportation corporation or a water transportation
15 corporation shall be apportioned by a fraction, the numerator of which is the corporation's revenue
16 ton miles in this State and the denominator of which is the corporation's revenue ton miles
17 everywhere. A qualified air freight forwarder shall use the revenue ton mile fraction of its
18 affiliated air carrier. The following definitions apply in this subsection:

19 (1) Air carrier. – A corporation engaged in the business of transporting any
20 combination of passengers or property of any kind by aircraft in interstate
21 commerce, and the majority of the air carrier's revenue ton miles everywhere
22 are attributed to transportation by aircraft.

23 (2) Air transportation corporation. – One or more of the following:

24 a. An air carrier that carries any combination of passengers or property of
25 any kind.

26 b. A qualified air freight forwarder.

27 (3) Qualified air freight forwarder. – A corporation that is an affiliate of an air
28 carrier and whose air freight forwarding business is primarily carried on with
29 the affiliated air carrier.

30 (4) ~~The term "revenue ton mile" means one mile.~~ – One ton of passengers,
31 freight, mail, or other cargo carried one ~~mile.~~ mile by the air transportation
32 corporation or water transportation corporation by aircraft, motor vehicle, or
33 vessel. In making this computation, a passenger is considered to weigh two
34 hundred pounds."

1 **SECTION 1.3.(b)** This section is effective for taxable years beginning on or after
2 January 1, 2016.

3 **SECTION 1.4.** G.S. 105-228.5(b)(4) reads as rewritten:

4 "(b) Tax Base. –

5 ...

6 (4) Self-insurers. – The tax imposed by this section on a self-insurer shall be
7 measured by the gross premiums that would be charged against the same or
8 most similar industry or business, taken from the manual insurance rate then in
9 force in this State, applied to the self-insurer's payroll for the previous calendar
10 year as determined under ~~Article 2 of Chapter 97~~ Article 36 of Chapter 58 of
11 the General Statutes modified by the self-insurer's approved experience
12 modifier."

13 **SECTION 1.5.** G.S. 105-130.7A(a) reads as rewritten:

14 "(a) Purpose. – Royalty payments received for the use of intangible property in this State
15 are income derived from doing business in this State. This section provides taxpayers with an
16 option concerning the method by which these royalties can be reported for taxation when the
17 recipient and the payer are related members. As provided in this section, these royalty payments
18 can be either (i) deducted by the payer and included in the income of the recipient, or (ii) added
19 back to the income of the payer and excluded from the income of the recipient. Exercising the
20 royalty reporting income option provided in this section does not prevent a taxpayer from having
21 taxable nexus in this State as otherwise provided in this Article and does not permit the recipient
22 of the income to exclude royalty payments from its calculation of sales as defined in
23 G.S. 105-130.4."

24 **PART II. PERSONAL TAX CHANGES**

25 **SECTION 2.1.(a)** G.S. 105-153.5(a) reads as rewritten:

26 "(a) Deduction Amount. – In calculating North Carolina taxable income, a taxpayer may
27 deduct from adjusted gross income either the standard deduction amount provided in subdivision
28 (1) of this subsection or the itemized deduction amount provided in subdivision (2) of this
29 subsection that the taxpayer claimed under the Code. The deduction amounts are as follows:

30 ...

31 (2) Itemized deduction amount. – An amount equal to the sum of the items listed in
32 this subdivision. The amounts allowed under this subdivision are not subject to
33 the overall limitation on itemized deductions under section 68 of the Code:

34 ...

35 c. Repayment in the current taxable year of an amount included in adjusted
36 gross income in an earlier taxable year because it appeared that the
37 taxpayer had an unrestricted right to such item, to the extent the
38 repayment is not deducted in arriving at adjusted gross income in the
39 current taxable year. If the repayment is \$3,000 or less, the deduction is
40 the amount of repayment less (i) the limitation provided under section
41 67(a) of the Code minus (ii) all other items deductible under section
42 67(b) of the Code, not to exceed the limitation provided under section
43 67(a) of the Code. If the repayment is more than \$3,000, the deduction
44 is the amount of repayment. No deduction is allowed if the taxpayer
45 calculates the federal income tax for the year of repayment under
46 section 1341(a)(5) of the Code."

47 **SECTION 2.1.(b)** G.S. 105-153.5(b) is amended by adding a new subdivision to read:

48 "(b) Other Deductions. – In calculating North Carolina taxable income, a taxpayer may
49 deduct from the taxpayer's adjusted gross income any of the following items that are included in
50 the taxpayer's adjusted gross income:
51

 2 (10) The amount added to federal taxable income under section 108(i)(1) of the
 3 Code. This deduction applies to taxable years beginning on or after January 1,
 4 2014."

5 **SECTION 2.1.(c)** This section is effective for taxable years beginning on or after
 6 January 1, 2014.

7 **SECTION 2.2.(a)** G.S. 105-153.5(c) is amended by adding a new subdivision to read:

8 "(c) Additions. – In calculating North Carolina taxable income, a taxpayer must add to the
 9 taxpayer's adjusted gross income any of the following items that are not included in the taxpayer's
 10 adjusted gross income:

11 ...
 12 (6) The amount of net operating loss carried to and deducted on the federal return
 13 but not absorbed in that year and carried forward to a subsequent year."

14 **SECTION 2.2.(b)** This section is effective for taxable years beginning on or after
 15 January 1, 2015.

16 **SECTION 2.3.** G.S. 105-163.1 reads as rewritten:

17 **"§ 105-163.1. Definitions.**

18 The following definitions apply in this Article:

19 ...
 20 (6) Individual. – Defined in ~~G.S. 105-134.1~~ G.S. 105-153.3.

 22 (13) Wages. – The term has the same meaning as in section 3401 of the Code except

33 **SECTION 3.1.** Section 2.4 of S.L. 2014-66 reads as rewritten:

34 **"SECTION 2.4.** ~~Sections 2.1~~ Section 2.1 of this act becomes effective July 1, 2013. Sections
 35 2.2 through 2.4 of this act become effective July 1, 2014. The remainder of this act is effective
 36 when it becomes law."

37 **SECTION 3.2.(a)** G.S. 105-164.3 reads as rewritten:

38 **"§ 105-164.3. Definitions.**

39 The following definitions apply in this Article:

- 4 are necessary to bring about a desired or appropriate effect. The person must do
- 5 more than calibrate, test, analyze, research, probe, or monitor the tangible
- 6 personal property or motor vehicle.
- 7 ~~(25a)~~(25b) Other direct mail. – Any direct mail that is not advertising and promotional
- 8 mail regardless of whether advertising and promotional direct mail is included
- 9 in the same mailing.
- 10 ~~(25b)~~(25c) Over-the-counter drug. – A drug that contains a label that identifies the
- 11 product as a drug as required by 21 C.F.R. § 201.66. The label includes either
- 12 of the following:

- 15 contained in the compound, substance, or preparation.

- 44 **SECTION 3.2.(b)** G.S. 105-164.3 reads as rewritten:
- 45 **"§ 105-164.3. Definitions.**
- 46 The following definitions apply in this Article:
- 47 ...
- 48 (44) Storage. – The keeping or retention in this State for any purpose, except sale in
- 49 the regular course of business, of tangible personal property or digital property
- 50 for any period of time purchased from a person in business.~~retailer. The term~~

1 does not include a purchaser's storage of tangible personal property or digital
2 property in any of the following circumstances:

3 a. ~~When the purchaser is able to document that at the time the purchaser~~
4 ~~acquires the property the property is designated for the purchaser's use~~
5 ~~outside the State and the purchaser subsequently takes it outside the~~
6 ~~State and uses it solely outside the State.~~

7 b. ~~When the purchaser acquires the property to process, fabricate,~~

13 **SECTION 3.2.(c)** Subsection (b) of this section becomes effective January 1, 2017.
14 The remainder of this section is effective when this act becomes law.

15 **SECTION 3.3.** G.S. 105-164.4B(e) reads as rewritten:

16 "(e) Accommodations. – The rental of an accommodation, as defined in
17 ~~G.S. 105-164.4(a)(3)~~, G.S. 105-164.4F, is sourced to the location of the accommodation."

18 **SECTION 3.4.** G.S. 105-164.4G(b) reads as rewritten:

19 "(b) Tax. – The gross receipts derived from an admission charge to an entertainment
20 activity are taxed at the general rate set in G.S. 105-164.4. The tax is due and payable by the
21 retailer in accordance with G.S. 105-164.16. For purposes of the tax imposed by this section, the
22 retailer is the applicable person listed below:

23 (1) The operator of the venue where the entertainment activity occurs, unless the
24 retailer and the facilitator have a contract between them allowing for dual
25 remittance, as provided in subsection (d) of this section.

26 (2) The person that provides the entertainment and that receives admission charges
27 directly from a purchaser.

28 (3) A person other than a person listed in subdivision (1) or (2) of this subsection
29 that receives gross receipts derived from an admission charge sold at retail."

30 **SECTION 3.5.** G.S. 105-164.4H(b) reads as rewritten:

31 "(b) Retailer-Contractor. – This section applies to a retailer-contractor when the
32 retailer-contractor acts as a real property contractor. A retailer-contractor that purchases tangible
33 personal property to be installed or ~~affixed~~applied to real property may purchase items exempt
34 from tax under a certificate of exemption pursuant to G.S. 105-164.28 provided the
35 retailer-contractor also purchases inventory items from the seller for resale. When the tangible
36 personal property is withdrawn from inventory and installed or ~~affixed~~applied to real property,
37 use tax must be accrued and paid on the retailer-contractor's purchase price of the tangible
38 personal property. Tangible personal property that the retailer-contractor withdraws from
39 inventory for use that does not become part of real property is also subject to the tax imposed by
40 this Article.

41 If a retailer-contractor subcontracts any part of the real property contract, tax is payable by the
42 subcontractor on the subcontractor's purchase of the tangible personal property that is installed or
43 ~~affixed~~applied to real property in fulfilling the contract. The retailer-contractor, the subcontractor,
44 and the owner of the real property are jointly and severally liable for the tax. The liability of a
45 retailer-contractor, a subcontractor, or an owner who did not purchase the property is satisfied by
46 receipt of an affidavit from the purchaser certifying that the tax has been paid."

47 **SECTION 3.6.** G.S. 105-164.4I(a)(3) reads as rewritten:

48 "(a) Tax. – The sales price of or the gross receipts derived from a service contract or the
49 renewal of a service contract sold at retail is subject to the general rate of tax set in G.S. 105-164.4
50 and is sourced in accordance with the sourcing principles in G.S. 105-164.4B. The retailer of a

1 service contract is required to collect the tax due at the time of the retail sale of the contract and is
2 liable for payment of the tax. The tax is due and payable in accordance with G.S. 105-164.16.

3 The retailer of a service contract is the applicable person listed below:

- 4 ...
- 5 (3) When a service contract is sold at retail to a purchaser by a facilitator on behalf
6 of the obligor under the contract and there is an agreement between the
7 facilitator and the obligor that states the obligor will be liable for the payment
8 of the tax, the obligor is the retailer. The facilitator must send the retailer the tax
9 due on the sales price of or gross receipts derived from the service contract no
10 later than 10 days after the end of each calendar month. The retailer must report
11 for the prior reporting period all tax received from the facilitator on or after the
12 first day of the month but before the tenth day of the month. A facilitator that
13 does not send the retailer the tax due on the sales price or gross receipts is liable
14 for the amount of tax the facilitator fails to send. A facilitator is not liable for
15 tax sent to a retailer but not remitted by the retailer to the Secretary. Tax
16 payments received by a retailer from a facilitator are held in trust by the retailer
17 for remittance to the Secretary. A retailer that receives a tax payment from a
18 facilitator must remit the amount received to the Secretary. A retailer is not
19 liable for tax due but not received from a facilitator. The requirements imposed
20 by this subdivision on a retailer and a facilitator are considered terms of the
21 agreement between the retailer and the facilitator."

22 **SECTION 3.7.(a)** G.S. 105-164.4D(b) reads as rewritten:

23 "(b) Determining Threshold. – A retailer of a bundled transaction subject to this section
24 may use either the retailer's ~~cost~~purchase price or the retailer's sales price to determine if the
25 transaction meets the fifty percent (50%) test or the ten percent (10%) test set out in subdivisions
26 (a)(1) and (a)(3) of this section. A retailer may not use a combination of ~~cost~~purchase price and
27 sales price to make this determination. If a bundled transaction subject to subdivision (a)(3) of this
28 section includes a service contract, the retailer must use the full term of the contract in determining
29 whether the transaction meets the threshold set in the subdivision."

30 **SECTION 3.7.(b)** G.S. 105-468 reads as rewritten:

31 "**§ 105-468. Scope of use tax.**

32 The use tax authorized by this Article is a tax at the rate of one percent (1%) of the ~~cost~~
33 purchase price of each item or article of tangible personal property that is not sold in the taxing
34 county but is used, consumed, or stored for use or consumption in the taxing county. The tax
35 applies to the same items that are subject to tax under G.S. 105-467. The collection and
36 administration of this tax shall be in accordance with Article 5 of Chapter 105 of the General
37 Statutes.

38 Where a local sales or use tax was due and has been paid with respect to tangible personal
39 property by the purchaser in another taxing county within the State, or where a local sales or use
40 tax was due and has been paid in a taxing jurisdiction outside the State where the purpose of the
41 tax is similar in purpose and intent to the tax which may be imposed pursuant to this Article, the
42 tax paid may be credited against the tax imposed under this section by a taxing county upon the
43 same property. If the amount of sales or use tax so paid is less than the amount of the use tax due
44 the taxing county under this section, the purchaser shall pay to the Secretary an amount equal to
45 the difference between the amount so paid in the other taxing county or jurisdiction and the
46 amount due in the taxing county. The Secretary may require such proof of payment in another
47 taxing county or jurisdiction as is deemed to be necessary. The use tax levied under this Article is
48 not subject to credit for payment of any State sales or use tax not imposed for the benefit and use
49 of counties and municipalities. No credit shall be given under this section for sales or use taxes
50 paid in a taxing jurisdiction outside this State if that taxing jurisdiction does not grant similar
51 credit for sales taxes paid under this Article."

1 **SECTION 3.7.(c)** G.S. 105-471 reads as rewritten:

2 "**§ 105-471. Retailer to collect sales tax.**

3 Every retailer whose place of business is in a taxing county shall on and after the levy of the
4 tax herein authorized collect the one percent (1%) local sales tax provided by this Article.

5 The tax to be collected under this Article shall be collected as a part of the sales price of the
6 item of tangible personal property sold, the ~~cost-purchase~~ price of the item of tangible personal
7 property used, or as a part of the charge for the rendering of any services, renting or leasing of
8 tangible personal property, or the furnishing of any accommodation taxable hereunder. The tax
9 shall be stated and charged separately from the sales price or ~~cost-purchase~~ price and shall be
10 shown separately on the retailer's sales record and shall be paid by the purchaser to the retailer as
11 trustee for and on account of the State or county wherein the tax is imposed. It is the intent and
12 purpose of this Article that the local sales and use tax herein authorized to be imposed and levied
13 by a taxing county shall be added to the sales price and that the tax shall be passed on to the
14 purchaser instead of being borne by the retailer. The Secretary of Revenue shall design, print and
15 furnish to all retailers in a taxing county in which he shall collect and administer the tax the
16 necessary forms for filing returns and instructions to insure the full collection from retailers, and
17 the Secretary may adapt the present form used for the reporting and collecting of the State sales
18 and use tax to this purpose."

19 **SECTION 3.8.(a)** G.S. 105-164.12B reads as rewritten:

20 "**§ 105-164.12B. Tangible personal property sold below cost with conditional ~~service~~**
21 **contract.**

22 (a) ~~Conditional Service-Contract Defined.~~ – A conditional ~~service~~-contract is a contract in
23 which all of the following conditions are met:

- 24 (1) A seller transfers an item of tangible personal property to a consumer on the
25 condition that the consumer enter into an agreement to purchase services on an
26 ongoing basis for a minimum period of at least six months.
- 27 (2) The agreement requires the consumer to pay a cancellation fee to the seller if
28 the consumer cancels the contract for services within the minimum period.
- 29 (3) For the item transferred, the seller charges the consumer a price that, after any
30 price reduction the seller gives the consumer, is below the purchase price the
31 seller paid for the item. The seller's purchase price is presumed to be no greater
32 than the price the seller paid, as shown on the seller's purchase invoice, for the
33 same item within 12 months before the seller entered into the conditional
34 ~~service~~-contract.

35 (b) ~~Tax.~~ – If a seller transfers an item of tangible personal property as part of a conditional
36 ~~service~~-contract, a sale has occurred. The sales price of the item is presumed to be the retail price
37 at which the item would sell in the absence of the conditional ~~service~~-contract. Sales tax at the
38 general rate under G.S. 105-164.4(a) is due at the time of the transfer on the following:

- 39 (1) Any part of the presumed sales price the consumer pays at that time, if the
40 service in the contract is taxable at the combined general rate.
- 41 (2) The presumed sales price, if the service in the contract is not taxable at the
42 combined general rate.
- 43 (3) The percentage of the presumed sales price that is equal to the percentage of the
44 service in the contract that is not taxable at the combined general rate, if any
45 part of the service in the contract is not taxable at the combined general rate.

46 (c)-(f) Repealed by Session Laws 2007-244, s. 3, effective October 1, 2007."

47 **SECTION 3.8.(b)** G.S. 105-467(a) is amended by adding a new subdivision to read:

48 "(a) ~~Sales Tax.~~ – The sales tax that may be imposed under this Article is limited to a tax at
49 the rate of one percent (1%) of the following:

50 ...

1 (8) The presumed sales price of an item of tangible personal property under
2 G.S. 105-164.12B."

3 **SECTION 3.9.(a)** G.S. 105-164.13(34) is repealed.

4 **SECTION 3.9.(b)** G.S. 105-164.13 is amended by adding a new subdivision to read:

5 "**§ 105-164.13. Retail sales and use tax.**

6 The sale at retail and the use, storage, or consumption in this State of the following tangible
7 personal property, digital property, and services are specifically exempted from the tax imposed
8 by this Article:

9 ...

10 (26b) Food, prepared food, soft drinks, candy, and other items of tangible personal
11 property sold not for profit for or at an event that is sponsored by an elementary
12 or secondary school when the net proceeds of the sales will be given or
13 contributed to the school or to a nonprofit charitable organization, one of whose
14 purposes is to serve as a conduit through which the net proceeds will flow to the
15 school. For purposes of this exemption, the term "school" is an entity regulated
16 under Chapter 115C of the General Statutes.

17 "

18 **SECTION 3.9.(c)** This section becomes effective January 1, 2017, and applies to sales
19 made on or after that date.

20 **SECTION 3.11.(a)** G.S. 105-164.13 reads as rewritten:

21 "**§ 105-164.13. Retail sales and use tax.**

22 The sale at retail and the use, storage, or consumption in this State of the following tangible
23 personal property, digital property, and services are specifically exempted from the tax imposed
24 by this Article:

25 ...

26 (52) Items subject to sales and use tax under G.S. 105-164.4, other than electricity,
27 telecommunications service, and ancillary service as defined in ~~G.S. 105-164.4,~~
28 G.S. 105-164.3, if all of the following conditions are met:

29 ...

30 (57) ~~Fuel and electricity~~ Fuel, electricity, and piped natural gas sold to a
31 manufacturer for use in connection with the operation of a manufacturing
32 facility. The exemption does not apply to the following:

33 a. ~~electricity~~ Electricity used at a facility at which the primary activity is
34 not manufacturing.

35 b. Fuel or piped natural gas that is used solely for comfort heating at a
36 manufacturing facility where there is no use of fuel or piped natural gas
37 in a manufacturing process.

38 "

39 **SECTION 3.11.(b)** This section becomes effective January 1, 2017.

40 **SECTION 3.12.(a)** G.S. 105-164.13E(c), as enacted by S.L. 2015-6, reads as
41 rewritten:

42 "(c) Contract with a Farmer. – A qualifying item listed in subdivisions (5), (8), and (9) of
43 subsection (a) of this section purchased to fulfill a contract with a person who holds a qualifying
44 farmer exemption certificate or a conditional farmer exemption certificate issued under

30 excise taxes are paid on wine or malt beverages, the ~~wholesaler, importer, or wine shipper~~
31 permittee ~~wholesaler or importer~~ must submit to the Secretary verified reports on forms provided
32 by the Secretary detailing sales records for the month for which the taxes are paid. The report must
33 indicate the amount of excise tax due, contain the information required by the Secretary, and
34 indicate separately any transactions to which the excise tax does not apply. A wine shipper
35 permittee shall submit verified reports once a year on forms provided by the Secretary detailing
36 sales records for the year the taxes are paid. The verified report is due on or before the fifteenth
37 day of the first month of the following calendar year."

 30 International Fuel Tax Agreement to aid in the administration of the
 31 Agreement."

32 **SECTION 4.5.(b)** G.S. 105-449.57(c) reads as rewritten:

 34 terms of an agreement, forward to officials of another jurisdiction any information in the

5 (10) Motor fuel sold to a hospital authority created under G.S. 131E-17."
